and a Tomlin 1.25 Tonne Hydraulic Trailer with rear lighting kit for **£2390.00.** After much discussion it was unanimously **RESOLVED** to authorise the funding from Section 106 monies as agreed by Broadland District Council.

5.2 – Much discussion took place around the three quotes for the resurfacing of the car park at Hellesdon Recreation Ground including essential works on the drainage provision. It was unanimously **RESOLVED** to appoint N R Asphalt as contractors for these works at a cost of £26,503.89; said work to begin as soon as possible – authority was given to the Council Administrator to run this project. It was further **RESOLVED** to request a donation of £6,000 from Hellesdon Library as a contribution to these works. Cllr. Prutton abstained from this vote.

5.3 – The Council Administrator led a discussion regarding the Health and Safety legislation pertaining to the Parish Council. It was unanimously **RESOLVED** to appoint Mr Alan Bunting to conduct a full inspection, review existing policies in line with current legislation and produce a report detailing necessary further actions at a cost of $\pounds1,000$.

5.4 – Discussion took place regarding a business plan which had been received from a Mr Wayne Steward which proposes to run a Carnival using the Hellesdon Recreation Ground and Community Centre. It was **RESOLVED** that the Council Administrator advise Mr Steward that the Council could not accommodate his request.
