5.2 – Feasibility report in respect of U16's play area. The committee chairman advised she had not had an opportunity to give this attention. In the interim 3 designs would be sourced from reputable companies with respective costings. Cllr King to liaise with Kevin Sage in this respect. The Clerk & the Chairman to explore funding opportunities with BDC.
