### **2     Declaration of Interest and Dispensations**

None declared.

### **3     Minutes of the last meeting**

**Minutes of the previous meeting held on the 29<sup>th</sup> August 2017 were agreed and signed as a true copy.**

### **4     Public Participation**

No public were in attendance.

### **5     General Matters**

**5.1**     It was **RESOLVED** for the Chairman of the Council to act as a key holder and provide an out of hours service until the appointment of a new Parish Clerk. Other members of staff to be contacted on a case by case basis.

**5.2**     Much discussion took place surrounding the appointment of a new senior member of staff. Consideration was given to amounts of hours, nature of the selection process, financing of the post's salary and the subsequent impact on both the staffing budget and also the Parish precept. The challenges of the role were discussed at length with a

particular focus on the future and the growing requirements and responsibilities of the Council, this also led to a discussion surrounding the requisite skills and experience needed from this new position.

**5.3** It was **RESOLVED** to schedule this item again to the next Staffing Committee meeting to allow current staffing issues to conclude.

**5.4** It was **RESOLVED** to postpone staff appraisals until the appointment of a new senior member of staff, such appraisals will then be conducted on January as previously resolved.
