## Norfolk County Council (Hellesdon) Emergency Notice Temporary Traffic Regulation Order 2024 Section 14(2) of the Road Traffic Regulation Act 1984

Hellesdon (NTRO8145) Notice

In accordance with the provisions of Section 14(2) of the Road Traffic Regulation Act 1984, the Norfolk County Council HEREBY GIVE NOTICE that owing to work being carried out on gas main to prevent loss of supplies the use by vehicles (of any class/specific class) of the A140 Cromer Road from its junction with Waldemar Avenue to its junction with Heather Avenue (the "Road") in the Parish of Hellesdon will be temporarily prohibited/restricted.

Alternative route is via: A140 Cromer Road, A1042 Mile Cross Lane/ Chartwell Road, A1151 Wroxham Road, A1270 Broadland Northway, A140 Holt Road (Hellesdon, Beeston St. Andrew, Spixworth, Horsford, Rackheath, Sprowston, Old Catton, Horsham St. Faith and Newton St. Faith).

The closure/restriction is necessary because of the likelihood or danger to the public or serious damage to the road or both.

The closure/restriction is anticipated to take place from 22nd to 23rd May 2024 but the Road may continue to be closed/restricted until the 11th June 2024 where the closure/restriction is still required beyond the anticipated dates.

This Notice shall be in effect from 22nd May to 11th June 2024 or until the closure/restriction is/are no longer necessary, whichever is the earliest.

This Notice shall automatically revoke on the completion of the works / when the closure/restriction is no longer necessary or otherwise on the 11th June 2024 without further notice.

If necessary, this Notice may be extended for an additional 21 days by further Notice and/or for a maximum of 18 months from the date this Notice is effective by further Order.

A person who contravenes, or who uses or permits the use of a vehicle in contravention of the restriction/ closure imposed by the Order shall be guilty of an offence.


Penalty: £1000 maximum fine on conviction and/or endorsement for contravention.
